



2022 Grant Guidelines

As your Catholic community foundation, we strive to make the granting process as open and clear as possible. Catholic Foundation grants address community needs within the three funding focus areas: social outreach, education/formation, and parish life. If you believe your project may be a fit with one or more of these priorities, we invite you to review the guidelines and eligibility requirements below and submit an online **Letter of Intent (LOI)**.

Catholic Foundation of Michigan Funding Eligibility

Before submitting an online LOI, please review the following requirements:

- Nonprofit entities in Michigan that serve communities primarily in Michigan.
 - The terms “nonprofit entity” and “organization” include Catholic parishes and Families of Parishes.
- The organization’s mission, values and behaviors are in line with [Catholic Teachings](#).
- Organization is a U.S. 501(c)(3) with audited financial statements.
- Project addresses one or more of the funding focus areas: social outreach, education/formation, and parish life.

We will not likely consider funding the following:

- Individuals
- Requests designated for endowment funds, deficit financing, capital campaigns, or loans.
- Programs operated to benefit for-profit organizations.
- Organizations that discriminate based on any federally protected status.

How to Apply

After reviewing the Catholic Foundation of Michigan guidelines and eligibility requirements for each grant type, applicants can create an account on our online Grant System. The online grant system link and additional information can be accessed by visiting: CatholicFoundationMichigan.org/grants/apply. Applicants will need to create an account on the online grants system if one has not already been created to submit an online (LOI). Once the LOI has been submitted and reviewed, applicants will be contacted and notified of eligibility via email by Foundation staff. - **Stage One: Letter of Intent (LOI) – Eligibility Application**
 - The LOI process will open on **April 28th** and will be accepted online by the Catholic Foundation of Michigan on or before **May 25th**. Once applicants have completed the online LOI process, you can expect to hear a decision within 30 days. Please understand that while all LOIs will be read, all may not generate an invitation to apply for funding. The Catholic Foundation of Michigan receives many compelling requests each year and regrettably, we are not able to fund each one.
- **Stage Two: Grant Application**
 - Once the LOI has been reviewed, applicants may be invited to submit a grant application online, due **July 31**. You are invited to call us to discuss your idea and to ask questions about the grant process. Please know that our staff is here to assist you with the application process, however, all funding decisions are made by the Catholic Foundation of Michigan Board of Directors at the fall quarterly meeting.

Catholic Foundation of Michigan Impact Grants:

Through the generosity of our faithful community, Impact Grants address needs within the Catholic Foundation of Michigan's three focus areas.

- **Empowering Social Outreach – \$1,000.00 - \$5,000.00** - Supports programs that respond to vital social services such as food, shelter, hope for those in despair and vulnerable within our community.
- **Building Vibrant Parish Life – up to \$1,000.00** - Aids parishes and programs that create a strong parish environment.
- **Fostering Catholic Education and Formation – up to \$1,000.00** - Grants to faith formation for people of every age. We encourage all stages of educational and spiritual development to enhance vibrant discipleship.

Impact Grant Eligibility Requirements:

- Meet the Catholic Foundation of Michigan funding eligibility stated on page 1.

Church in the City Grants:

Through the generosity of the Archdiocese of Detroit, these grants are awarded to projects in line with the 2017 pastoral letter *Unleash the Gospel* and that propagate the Catholic faith in the cities of **Detroit, Hamtramck, and Highland Park**. Grants awarded will be between \$1,000.00 and \$5,000.00.

Church in the City Grant Eligibility Requirements:

- Meet the Catholic Foundation of Michigan funding eligibility stated on page 1.
- A Catholic Parish, school, or organization found in the official [Catholic Directory \(Kennedy\)](#).
- Organization must be headquartered or located in one of the following cities: Detroit, Hamtramck, or Highland Park.
- Meet one or more of the funding focus areas: evangelization, social Outreach, parish Life, Catholic education/formation.

St. Oscar Romero Grant for Hispanic and Latino Ministries:

Thanks to the generosity of the Holy Trinity Parish in Port Huron, this \$1,000 grant seeks to invest in creative programs that strengthen the diverse Latino community of Michigan and support issues and organizations that advance the socio-economic status, spiritual growth, and leadership capacity of the entire Latino community.

St. Oscar Romero Grant Eligibility Requirements:

- Meet the Catholic Foundation of Michigan funding eligibility stated on page 1.
- Parish, school, or organization that improves the quality of life of the Latino population in the [Northeast Region of the Archdiocese of Detroit](#).



Spirit of Innovation Grants:

Through “Spirit-led” grants, ministries in the **Archdiocese of Detroit** will be able to develop, launch and grow new initiatives, ministries and approaches that share the good news with all, forming joyful missionary disciples. The grants are awarded to projects that activate initiatives to serve beyond the work of individual parishes, inspire disciples to dream and innovate, attract national ministries and organizations and respond to future inspirations of the Holy Spirit. One grant will be awarded this year in the amount of \$7,500.00.

Spirit of Innovation Grant Eligibility Requirements:

- Meet the Catholic Foundation of Michigan funding eligibility stated on page 1.
- Catholic Parish, school, or organization in the Archdiocese of Detroit.
- A new initiative using new ideas, methods, creative approaches, or solutions to Unleash the Gospel.
- Show collaborative partners (local businesses, ministries, associations, or outreach groups) in place to increase community involvement.
- Identify at least 1 Guidepost from the 2017 pastoral letter, [*Unleash the Gospel*](#), that your project will boldly articulate.

Sanctity of Life Grant:

The Sanctity of Life Endowed Grant was established in memory of Marisa Petrella, a dedicated servant leader. This grant will provide funding to support creative programs that build a holistic reverence for life, promoting life and dignity of the human person as outlined by Catholic Teaching. *Political projects are discouraged from applying.*

Sanctity of Life Grant Eligibility Requirements:

- Meet the Catholic Foundation of Michigan funding eligibility stated on page 1.
- Project must build upon the [Church’s teaching on the sanctity of the human person](#) from the moment of conception through the moment of natural death.

Brian V. Hill Foundation for Marriage and Family Grant:

The Brian V. Hill grant was established to enhance the spiritual understanding of Theology of the Body as an image of God’s divine love in the Catholic community of Michigan. The grant seeks to invest in creative programs that promote Theology of the Body education and/or training for teachers or facilitators of Theology of the Body Programs that provide hands-on for students.

Brian V. Hill Grant Eligibility Requirements:

- Meet the Catholic Foundation of Michigan funding eligibility stated on page 1.
- Organization and project promote [Theology of the Body](#).
